-STUDIO DATES~

Session I: September 13 - December 18
Holiday Break: December 19 - January 2

Session II: January 3 - April 30
No Class on Halloween NIGHT & Thanksgiving night
No Class the week of Spring Break—March 28 to April 2

IMPORTANT DUE DATES~

Session I tuition is due Sept. 16th. If payment is received after the 16th, a \$5 per class late fee will occur.
Costume payments are due Dec. 16th. If payment is received after the 16th, a \$10 per costume late fee will occur.
Session II tuition is due Dec. 16th. If payment is received after the 16th, a \$5 per class late fee will occur.

- CLASS ATTIRE~

Ballet/Tap, Girls: Any style leotard, any style ballet skirt if desired, and pink, white or black tights.

Jazz, Girls: Any style leotard, jazz pants or skirt, and pink, white, or black tights or socks.

Ballet/Tap/Jazz, Boys: Black sweatpants or running pants, plain style tee shirt, and socks if desired.

- PROPER DANCE SHOES~

Girls: Pink Leather Ballet Shoes, Black Tap and Black Jazz Shoes

Boys: Black Leather Ballet Shoes, Black Tap and Black Jazz Shoes

-MISSED CLASSES~

Dancers are welcome to make up any classes in any of our comparable class times. Just let the instructor know.

-TUITION~

If you are registering during early registration you must pay a minimum of a full costume payment to hold your class spot. Tuition must be paid by the first week of the session. If it is not, your account will be charged a \$5 per class late fee. If tuition is not paid, including the late fee, by the third week of class your dancer will be removed from class. If you choose the monthly payment option, you're fully agreeing to pay a full seven payments, per agreed and signed upon (Please see additional sheet). If your dancer withdraws from classes, the remaining month's worth of payments will be made. There are no class refunds given for any reason.

-RECITAL~

Our Spring Recital is a wonderful show! Each class gets an awesome costume that is purchased. (Cost due by Dec. 16th) Our spring show is traditionally scheduled for the second weekend in May, though it fully depends on the auditorium's availability! The date will be confirmed by February. Tickets, which will go on sale in April, are sold to offset the cost of the auditorium. As well, we have a full costume & make up dress rehearsal, at the auditorium in the week prior. Recital is not mandatory, but it is an experience that allows our dancers to perform and add to their full dance experience.
